## Register now for pre-Expo inspector and O&M workshops

Join us for the two days before the Pumper & Cleaner Expo, Monday and Tuesday, February 22–23, 2010, in Louisville, Kentucky, to take part in NAWT's nationally acclaimed workshops! Once again, NAWT will offer its two-day onsite inspector training course and, for the first time at the show, its two-day, 12-hour onsite operation and maintenance (O&M) course. The one-day vacuum truck technician training course will also be held on Tuesday, February 23.

The inspector course is at the operation level. The first day covers the basics of sewage treatment and system types using a troubleshooting perspective. The second day goes through a step-by-step procedure to conduct a system inspection. It requires attendees to locate and identify all parts of the system, assess their condition, and determine if they are operating properly. Instructors for this course will be the nationally acclaimed Dave Gustafson and Jim Anderson, and Tim Frank of Tim Frank Septic Tank Cleaning, Huntsburg, Ohio. Between them, they have more than 60 years of experience with onsite treatment systems.

Running concurrently with the inspection course will

be the special NAWT Operation and Maintenance Course designed specifically for the Expo. Topics include operating and maintaining septic tanks, ATUs, media filters and drip irrigation systems. In addition to Dave, Jim, and Tim, the instructors will include Tom Frank of Tim Frank Septic Tank Cleaning, Huntsburg, Ohio, and Kit Rosefield, Accredited Septic System Monitoring of Mi Wuk Village, California. They bring their years of expertise in owning and operating businesses that operate and maintain systems.

What roles can the pumper play in your community to ensure that these systems are operated and managed properly to ensure protection of public health and the environment?*

Best of all, both the inspection and the O and M course will have hands-on and field opportunities through the cooperation of Bullitt County Septic Services. In previous years in Louisville, field site opportunities have been provided by Dave Ritchie of Zaring. Dave Ritchie did a great job, and we will work with Zaring again in the future. This year, Bullitt County Septic Services offers an opportunity to see a different area and to tour their unique systems south of Louisville. As always, an exam for certification will be given for both the inspection and O and M certification.

NAWT's vacuum truck technician training course is for new owners and employees who operate vacuum trucks to clean septic tanks, aerobic treatment units, holding tanks, or grease traps. It can also serve as a refresher course and overview for experienced operators. Training

includes presentations, videos, and hands-on exercises with a pump truck.

# NAWT partners to offer Massachusetts Title 5 education credits

NAWT is pleased to team up with Massachusetts Title 5 Inspector Al Rivet to present the two-day NAWT inspection course on Tuesday and Wednesday March 16 and 17, 2010. The course will be held at the Holiday Inn in Taunton, Massachusetts. This course fully qualifies for the required 10 hours of continuing education to maintain Title 5 certification for point-of-sale sewage system inspections.

On the first day of the two-day inspection course, the basics of sewage treatment and system types are covered from a troubleshooting perspective. The second day goes through the step-by-step procedure to conduct a system inspection.

As part of the inspection training, we will actually go into the field and perform a system inspection!

Those who wish to be NAWT certified may take the exam administered at the end of the course. Contact information for inspectors who have passed the certification exam will be listed on the NAWT national website. This certification is increasingly recognized as setting the national standard for residential septic system inspections. Instructors for the workshop are Dave Gustafson, Jim Anderson, and Al Rivet.

The vacuum truck driver training is designed primarily for those new to vacuum trucks and their operation. The course will be offered on Monday, March 15, 2010, in Taunton. It is also a good refresher for experienced drivers. NAWT encourages business owners to take this course to evaluate if it helps fill their training needs for new employees.

The course is offered in classroom settings such as this and online so individuals can work through the course on their own.

Upon conclusion of the course, participants should be able to recognize trucks and their associated equipment, understand the equipment's functions, understand the vocabulary of pumping, know how to apply safety principles, how to operate the equipment safely, how to recognize which materials to avoid, how the job is regulated by government, and how to speak to customers with confidence. The instructor for this course will be Tom Ferrero, NAWT Executive Director.
